FINANCIAL ASSISTANCE TO STUDENTS FOR PURSUING PROFESSIONAL STUDIES (AY 2025-26 JOINING)

Applications in the prescribed format (enclosed) are invited for grant of Financial Assistance in terms of the scheme for extending financial assistance to students of peripheral areas of Rourkela Steel Plant or any village coming under any of the revenue blocks of Sundargarh District, Odisha. This is a CSR endeavor of Rourkela Steel Plant to promote professional education among the weaker sections of the society.

ELIGIBILITY: The eligibility criteria under the scheme will be as follows.

- 1. The student should be resident of any resettlement colony/camp of Rourkela Steel Plant or any village coming under any of the revenue blocks of Sundargarh district, Odisha.
- 2. The student should have obtained admission in the professional course, in the Academic Year 2025-26 in a recognized institution under the following professional courses,
 - i. Graduation course in Engineering, Medical or Agriculture (including integrated/dual degree M.Tech. Course) OR
 - ii. Post Graduation course of at least two years duration in Engineering/ Medical/ Agriculture/ Business Administration.
- 3. The student, whose parents (taken together) are having annual income from all sources **not exceeding** Rs. 2,50,000.00 (Rupees Two Lakhs Fifty Thousand Only), shall be eligible for the financial assistance.
- 4. For Graduation Courses (including integrated/dual degree M.Tech. Course), preference shall be given as follows:
 - 1st Priority: SC/ST Students pursuing professional course of at least 4-years duration.
 - 2nd Priority: SC/ST Students professional pursuing course of less than 4-years duration (e.g. through lateral entry after Diploma in Engineering).
 - 3rd Priority: Other than SC/ST Students pursuing professional course of at least 4-years duration.
 - 4th Priority: Other than SC/ST Students pursuing professional course of less than 4-years duration (e.g. through lateral entry after Diploma in Engineering).
- 5. For Post-Graduation Courses, first preference shall be given to SC/ST candidates. In case of non-availability of such candidates, other than SC/ST candidates shall be considered.

FINANCIAL ASSISTANCE:

- 1. The amount of financial assistance under the scheme will be as follows.
 - i. For Graduation Courses of 4-years duration (e.g. B.Tech/B.Sc(Engg.)/B.Sc(Ag) etc.), the total amount of financial assistance will be Rs.1,20,000/-.
 - ii. For Graduation Courses of less than 4-years duration (e.g. Lateral entry in B.Tech/B.Sc(Engg.) after Diploma in Engg.), the total amount of financial assistance will be Rs.90,000/-.
 - iii. For Graduation Courses of more than 4-years duration (e.g. 5-yr MBBS, 5-yr integrated/ dual degree M.Tech.), the total amount of financial assistance will be Rs.1,50,000/-.
 - iv. For Post Graduation Courses of at least 2-years duration (e.g. M.Tech./MD/MS/ M.Sc.(Ag)/MBA etc.), the total amount of financial assistance will be Rs.60,000/-.
- 2. The financial assistance amount will be released in equal yearly installments, not exceeding Rs.30,000/- in one installment, through **e-payment mode** in favour of the student concerned.
- 3. The first installment of the financial assistance will be released after selection of the candidates. The subsequent installment(s) will be released on submission of documentary evidence of continuation in the course by the beneficiaries after passing the previous year's examination.



METHODOLOGY:

- 1. Applicants are required to furnish self attested copies of the following documents along with application in the prescribed format.
 - i. Documentary proof of belonging to SC/ST (Certificate from Tahasildar, Govt. of Odisha or higher authority), if applicable.
 - ii. Proof of being resident of any resettlement colony/camp of Rourkela Steel Plant or any village coming under any of the revenue blocks of Sundargarh district, Odisha (Certificate from Tahasildar, Govt. of Odisha or higher authority).
 - iii. Mark sheets of the examinations passed.
 - iv. Bona-fide studentship certificate/continuation certificate from the institution where admission obtained.
 - v. Employment details of the parents along with income certificate.
- Best 20 students (10 Girls & 10 Boys) for Graduation Courses (including 5-years integrated/ dual degree M.Tech.) and Best 10 Students (5 Girls & 5 Boys) for Post-Graduation Courses shall be selected from the merit list of the eligible applicants, prepared separately for Girls & Boys.
 - However, in case there is a shortfall in number of selected candidates in either of the categories i.e Boys or Girls for which merit lists are prepared separately, then the applicants from the merit list of the other category may be additionally selected for the scholarship keeping the total number of scholarships as 20 in case of Graduation courses and 10 in case of Post-Graduation courses.
 - For example, for Graduation courses; in case the number of Girls who fulfill the eligibility criteria for the scholarship is less than 10 and the number of Boys who fulfill the eligibility criteria is more than 10, then, the shortfall in the Girls selection list shall be made up by selecting additional number of boys as per merit, from the list prepared for Boys for grant of the scholarship, keeping the total number of scholarships as 20.
- 3. For the Graduation Courses (including 5-years integrated/dual degree M.Tech. course), inter-se merit list of the applicants will be prepared on the basis of marks/percentage of marks (excluding extra optional) obtained in the Class-12 (Plus Two)/equivalent examination (Diploma in Engineering in case of lateral entry). In case of tie, the marks secured in the Class-10 or equivalent examination shall be reckoned.
- 4. For the Post-Graduation Courses, inter-se merit list of the applicants will be prepared on the basis of aggregate marks/percentage of marks secured in the qualifying graduation course concerned. In case of tie, the marks secured in the Class-12 or equivalent examination shall be reckoned.
- 5. Decision of the Management of SAIL, Rourkela Steel Plant, in the matters of selection and/or continuation of the financial assistance shall be final and binding on all concerned.

The duly completed application in the prescribed format along with required documents should be submitted in a sealed envelope at the office of the **General Manager I/c**, **CSR Department**, **IPD Building**, **Sector-20**, **Rourkela-769005** latest by 30/11/2025 either in person or by post so as to reach by the above date. Please note that no application will be accepted thereafter. Incomplete applications and applications without supporting documents will be liable to be rejected.
